- 2. Restructure the criminal case assignment system such that Senior Judge Aronovitz' draw becomes henceforth 70 percent of all criminal cases assigned in criminal case category I and II assignments only.
- 3. Remove Senior Judge Aronovitz from the criminal case assignment system for all criminal case category III, IV, and V assignments.
- 4. Remove Senior Judge Aronovitz from all <u>habeas corpus</u> petition case assignments wherein the prisoner is under a sentence of death.
- 5. Remove Senior Judge Aronovitz from the monthly Duty Judge assignment wheel.
