ADOPTION OF NEW LOCAL RULES AND REVOCATION OF ALL PREVIOUSLY EXISTING LOCAL RULES

Pursuant to Title 28, United States Code, Section 2077 (b), the Advisory Committee on Rules and Procedures of the Southern District of Florida recommended to the Court the complete revision of the district's local rules. Following a lengthy and exhaustive undertaking, the committee presented to the Court their proposed new local rules. The Court, having given notice pursuant to 28 USC § 2071 (b) and Fed.R.Civ.P. 83, held a public en banc hearing on September 8, 1992, in the Central Courtroom, United States Post Office and Courthouse, Miami, Florida, to consider the committee's proposed new local rules.

The Court, having taken testimony from those individuals present at the en banc hearing, and on its own motion, does hereby

ORDER, ADJUDGE, AND DECREE, effective Monday, February 15, 1993, the United States District Court for the Southern District of Florida, revokes all previously issued local rules of the court, and adopts, pursuant to 28 USC § 2071 (f) and Fed.R.Civ.P. 83, the proposed new local rules submitted by the Advisory Committee on Rules and Procedures of the Southern District of Florida. The new local rules shall have effect on pending proceedings at the discretion of the respective judge presiding.

In accordance with 28 USC § 2071 (d) and Fed.R.Civ.P. 83, the Clerk of Court will furnish a copy of the new local rules, together with a copy of this order, to the Eleventh Circuit Judicial Council and the Director of the Administrative Office of the United States Courts. Furthermore, the Clerk of Court will give appropriate public notice of the adoption of the new local rules and arrange for the public to obtain copies of the new rules.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that all previously issued administrative orders of the United States District Court for the Southern District of Florida, embracing declarations which are in conflict with the new local rules be held

null and void of any force and effect as of this date.
