ADMINISTRATIVE ORDER NO. 93-07

IN RE:

TRANSFER OF JUDGE KENNETH L. RYSKAMP'S PLACE OF ABODE FROM MIAMI TO WEST PALM BEACH

On January 8, 1992, at a regularly scheduled meeting of the Judges of the Southern District of Florida, the Court considered Judge James C. Paine's election to take senior status effective May 21, 1992, and voted to recommend to the Eleventh Circuit Judicial Council that West Palm Beach be designated as the place of abode for Judge Paine's replacement. Judge Paine's elevation created a situation in West Palm Beach where two active judges were authorized yet none were resident, further complicated by the rapid growth of new filings in the district's northern division.

On February 12, 1992, Judge Kenneth L. Ryskamp acknowledged the problem and in the public interest, and for the benefit of the Court, notified Chief Judge Norman C. Roettger, of his decision to relocate his place of abode from Miami to West Palm Beach, effective September 3, 1992.

On March 19, 1992, the Eleventh Circuit Judicial Council issued General Order 92-B, designating Judge Paine's successor's place of abode as West Palm Beach, in accordance with 28 U.S.C. § 134(c). Also on that date, Eleventh Circuit Chief Judge Gerald Bard Tjoflat notified the director of the Administrative Office of the United States Courts of the Judicial Council's order, and, further, that Judge Kenneth L. Ryskamp would change his place of abode from Miami to West Palm Beach. Finally, Chief Judge Tjoflat stated, the place of abode of the judge appointed to fill Judge Paine's vacancy will be Miami, Florida. Therefore, it is

ORDERED, ADJUDGED, AND DECREED, the place of abode of Judge Kenneth L. Ryskamp be transferred from Miami, Florida to West Palm Beach, Florida, effective September 3, 1992.
