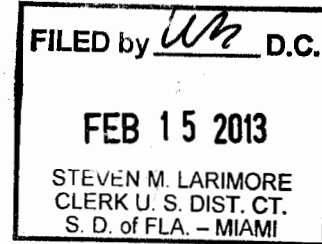

RANDOM DESIGNATION OF EXPIRING TERMS
OF CURRENT PANEL MEMBERS**



Administrative Order 2013-11, entered on February 13, 2013, amended the Amended CJA Plan's procedure for removing a panel member during his or her term of service. A Conduct Review Panel was established consisting of the Court's Liaison to the Committee and another U.S. District Judge appointed by the Chief Judge. Judge Marcia Cooke, together with the Court's current Liaison to the CJA Panel Committee, Judge Robert N. Scola, Jr., shall constitute the Conduct Review Panel as described in paragraph F of the Amended CJA Panel Plan.

That same Administrative Order also provided for the Panel Members to serve staggered three year terms with one third of the Panel's terms expiring each year commencing in September 2013. Attached to this order are the three randomly selected lists designating the expiring terms.
