
Pursuant to Title 18, United States Code, Section 3006A (h) (2) (a), the Guidelines for the Administration of the Criminal Justice Act, Vol. VII, para. 4.02A, the Eleventh Circuit Court of Appeals' policy concerning Selection and Appointment of Federal Public Defenders, and in recognition of the May 29, 1990 expiration of the incumbent Federal Public Defender's appointment, a Committee on the Appointment of the Federal Public Defender is hereby established.

Effective this date, Judge William J. Zloch is appointed committee chairman. Judge Eugene P. Spellman, Judge Stanley Marcus, and Judge Thomas E. Scott are each appointed as committee members.

The committee is charged with coordinating the position announcement which shall be publicly posted no later than October 30, 1989. The committee shall screen all applications received, and make recommendations to the District Court, no later than January 12, 1990 about each of the applicants qualified under paragraph 5(a), Addendum Seven, Rules of the Eleventh Circuit.


