**ORDER OF CONSOLIDATION SOLELY FOR THE  
PURPOSE OF ENTERTAINING MOTION TO REMAND**

THIS MATTER has come before the Court as a result of a number of petitions for removal filed by third-party defendant, Surinaamse Luchtvaart Maatschappij, N.V., a/k/a Surinam Airways, Ltd. ("Surinam Airways"), and the Court is advised that other such petitions will be filed. The cases in question all arise out of an aircrash which occurred on June 7, 1989 in Surinam. Approximately 60 wrongful death and personal injury actions were filed in Circuit Court for the Eleventh Judicial Circuit in and for Dade County, Florida. On January 10, 1990, third-party defendant Surinam Airways filed its petition for removal in the first of these cases, and the others have followed. The lawfirm representing many of the Plaintiffs has advised the Court that they intend to file a Motion for Remand.


This Court finds that it would be in the interest of judicial economy that all actions presently pending or to be before this Court relating to the Surinam aircrash be consolidated solely for the purpose of consolidation of the Plaintiffs' anticipated Motion

for Remand. This Order of consolidation is for the limited purpose of resolving this issue, and is done without undertaking the formal transfer of any of the pending actions.

This Court recognizes that Rule 6(c) of the Local Rules of this Court provides that in transferring similar proceedings, in order to avoid duplication of judicial labor, the reassignment should be to the lower-numbered action -- in this case, to the Honorable William M. Hoeveler, Case No. 90-0054. However, after conferring with the Honorable William M. Hoeveler and the Honorable Kenneth Ryskamp, this Court has determined that it would be in the interest of all concerned that these cases be assigned to the Honorable Kenneth Ryskamp, for the limited purpose of determining the issue of remand.

Because this Order of Limited Consolidation deviates from Rule 6(c) of the Local Rules of this Court, the Court will entertain any objections to this Order, to be filed with the Chief Judge no later than 5:00 p.m. on Thursday, January 25, 1990. Each case is consolidated on the issue of remand only before the Honorable Kenneth Ryskamp, without the necessity of any further action by any of the parties.
