ADMINISTRATIVE ORDER NO. 93-03

IN RE:

**DESIGNATION OF ALL SOUTHERN
DISTRICT COURTHOUSES AND
OFFICES AS SMOKE FREE FACILITIES**

Previously, this court issued administrative orders¹ promulgating "No Smoking" regulations for the courthouses and offices occupied by the United States District Court, Southern District of Florida in accordance with the Federal Property Management Regulations (FPMR), Title 41 CFR § 101-20.105-3.

Recently, the Environmental Protection Agency released a report stating secondhand cigarette smoke is a proven human carcinogen in the same class as asbestos, benzene and radon, and is responsible for the deaths of approximately 3,000 nonsmokers each year. In light of this information, it is therefore

ORDERED, ADJUDGED, AND DECREED, all courthouses and office facilities occupied by the United States District Court for the Southern District of Florida are designated **"SMOKE FREE FACILITIES."** This order applies equally to all employees of the court, its component units, jurors and witnesses, employees of related government agencies occupying offices in facilities wherein the court is the facility's majority tenant, members of the bar, and the general public, and supercedes all previous administrative orders. It is further

ORDERED, ADJUDGED, AND DECREED, signage, consistent with 41 CFR 101-20.105-3(e), indicating the respective courthouse or office has been designated a **SMOKE FREE FACILITY, THEREFORE SMOKING IS NOT PERMITTED IN ANY INTERIOR SPACES OF THE FACILITY,** shall be posted at the entrance of each courthouse or office.
