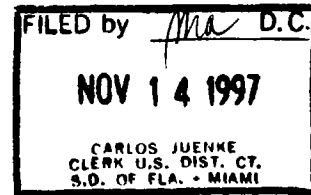

AMERICAN AIRLINES CASES**




In accordance with the assignment policy of this Court, and in the interest of justice and expediency pursuant to S.D. Fla. L.R. 3.4, it is hereby
