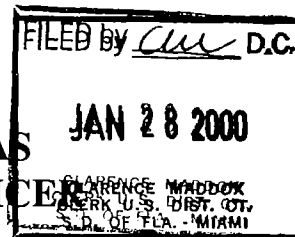

IT APPEARING that a vacancy exists for a Chief United States Pretrial Services Officer in the United States District Court for the Southern District of Florida, and


IT FURTHER APPEARING that Title 18 U.S.C. § 3152 requires selection of a Chief United States Pretrial Services Officer by a panel consisting of the Chief Judge of the Circuit or his designee, the Chief Judge of the District or his designee, and a Magistrate Judge of the District, and

IT FURTHER APPEARING that United States Circuit Judge Stanley Marcus, Chief United States District Judge Edward B. Davis, and United States Magistrate Judge Lurana S. Snow of the District have conferred and are unanimous in their view that BONNIE PHILLIPS-WILLIAMS is well qualified to perform the duties of Chief United States Pretrial Services Officer for the Southern District of Florida. It is

ORDERED that BONNIE PHILLIPS-WILLIAMS be, and she is hereby, appointed Chief United States Pretrial Services Officer for the Southern District of Florida, effective January 31, 2000, from her provisional appointment as Acting Chief Pretrial Services Officer, and as such shall have such powers as are fixed by the Statutes of the United States relating to such matters. It is further

ORDERED that the Clerk of Court will cause certified copies of this order to be entered upon the record of this Court, and shall forward a certified copy of this order and the appropriate documents of appointment to the Administrative Office of the United States Courts.
