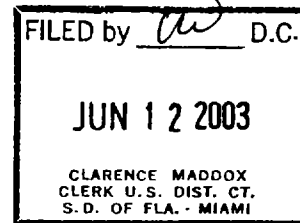

0:03cv60685, Direct TV v. Glaser, is herein randomly reassigned to the Honorable James Lawrence King.


0:03cv60929, US v. Acunto, is herein randomly reassigned to

Magistrate Judge Lurana S. Snow or the Magistrate Judge currently assigned to these cases shall effect the transfer of these cases to the Magistrate Judge who is currently paired with the newly-assigned District Judge pursuant to Administrative Order 2002-02 or 2002-36 by certifying that all pending fully briefed motions have been resolved and ordering that the Clerk transfer the cases to new Magistrate Judge. Those cases which are not referred may be administratively transferred to the new Magistrate Judge by the Clerk upon the direction of Magistrate Judge Snow or the currently-assigned Magistrate Judge. The Clerk shall promptly execute the transfers to the new Magistrate Judge, and upon doing so shall immediately change the case's magistrate judge designation.

The Clerk's Office is directed to ensure that counsel of record in all transferred cases is noticed of the transfer via the Court's Faxback program.
