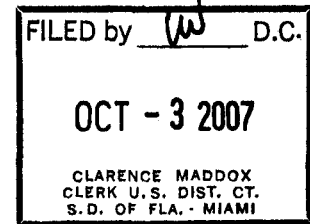

ORDER OF DISBARMENT

It has been shown to the Court that the Supreme Court of Florida has disbarred the above-named attorney from practicing law in Florida, effective 30 days following an Order dated October 10, 2002. This matter was referred to the *Ad Hoc Committee on Attorney Admissions, Peer Review and Attorney Grievance* for a recommendation. The Committee conducted an intrinsic review of the entire record provided by Mr. Karten, including but not limited to, Mr. Karten's Response to the Order to Show Cause, Respondent Supplemental Response [*sic*] and Clarification of Respondent's Position, Response to the Second Supplemental Order to Show Cause and Referral to Disciplinary Committee for Final Report and Recommendation, and the record of state court proceedings which led to his disbarment including Mr. Karten's Motion for New Trial and the proceedings thereon. After that review, the Committee recommended that he be disbarred. The Committee found that the state court proceedings complied with due process, that there was no infirmity in the proof establishing misconduct that would give rise to a clear conviction that this Court cannot accept the disbarment as final, and, consequentially, that reciprocal disbarment would not be contrary to fairness and justice. Further, it is noted that the Court received and considered Mr. Karten's Response to the Committee's Final Report dated September 20, 2007. It is hereby

ORDERED pursuant to the Rules Governing Attorney Discipline, United States District Court, Southern District of Florida, that said attorney be disbarred from practice in this Court, effective 30 days following the Supreme Court of Florida's Order dated October 10, 2002.

IT IS FURTHER ORDERED by this Court that said attorney advise the Clerk of the Court of all pending cases before this Court in which he is counsel or co-counsel of record, and

IT IS FURTHER ORDERED by this Court that the Clerk of Court mail Alan Ira Karten a copy of this Order of Disbarment.
