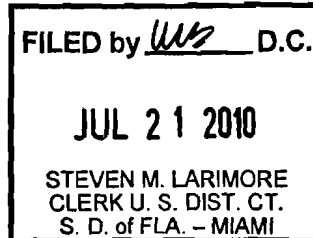

ADMINISTRATIVE ORDER 2010-95

IN RE: APPOINTMENT OF COMMITTEE
TO OVERSEE EVENTS COMMEMORATING
