JUDGE PAIRING ASSIGNMENT PLAN

All Administrative Orders on the Magistrate Judge Pairing Assignment Plan are hereby amended due to the elevation of Judge Robin S. Rosenbaum to the District Court. Wherefore, it is

ORDERED that based on Judge Rosenbaum's appointment as a District Judge, Magistrate Judge William Matthewman will be paired with Judge William Zloch for criminal cases and Magistrate Alicia M. Otazo-Reyes will be paired with Judge William Zloch for civil cases. Both Magistrate Judges will inherit all of the cases pending before Judge Rosenbaum, while she served as a Magistrate Judge. Also, Magistrate Judge Seltzer will be paired with District Judge Rosenbaum for civil cases and Magistrate Judge Snow for criminal cases. It is also
