Earlier this year, the Court entered Administrative Order 2014-25 directing the reassignment of 21 pending cases from the docket of Senior District Judge William M. Hoeveler's in anticipation of his pending retirement. At the present time, seven additional cases on Judge Hoeveler's docket are ripe for reassignment. Pursuant to Sections 2.10.00 and 3.03.00 of the Internal Operating Procedures, it is herein

ORDERED that effective immediately, the attached list of seven cases currently assigned to Senior District Judge William M. Hoeveler will be reassigned as reflected in the attached listing, which was created by the Clerk's Office through a random selection process and provided to the undersigned for inclusion in this Order; It is

FURTHER ORDERED that as to the earlier reassignments made pursuant to Administrative Order 2014-25, most active Judges received one case, although five active Judges received two cases. Therefore, the Clerk was directed to exclude the five judges who already received two cases previously from the current reassignment, so that those seven cases have been randomly reassigned among the remaining District Judges. It is

FURTHER ORDERED that the Magistrate Judge on all transferred cases shall be administratively changed by the Clerk to the paired Magistrate Judge of the newly assigned District Judge. The newly assigned District Judges shall decide whether any previously referred

matters shall be handled by their paired Magistrate Judge, or whether those previous referrals shall be terminated; it is

FURTHER ORDERED that the Clerk's Office will make a notation on the docket of each case reflecting the fact that the case has been transferred upon the authority of this Administrative Order, and each counsel and *pro se* party of record will receive notification through the CM/ECF procedures or by mail. Because this Administrative Order is available for public viewing on the Court's website, a copy of this Administrative Order need not be docketed in each case.
