The Panel will meet in person as necessary, and after consideration of comments and feedback obtained, will make a recommendation to the Court by October 31, 2017.

All Panel members have been advised in writing of the restriction set forth in § 420.30.20(d) of the Regulations of the Judicial Conference of the United States Establishing Standards and Procedures for the Appointment and Reappointment of United States Magistrate Judges.
