ORDER OF SUSPENSION

The Supreme Court of Florida has entered an Order of Suspension dated July 13, 2017, suspending Cindy LoCicero Runyan from the practice of law for ninety-one (91) days. *See The Florida Bar v. Runyan*, No. SC17-918, 2017 WL 2982124 (Fla. July 13, 2017). The suspension was predicated on The Florida Bar’s Petition for Contempt and Order to Show Cause and the attorney’s failure to file a response to the Supreme Court of Florida’s Order to Show Cause. The Clerk served attorney Runyan by certified mail with an Order to Show Cause why this Court should not impose the same discipline, accompanied by the Supreme Court of Florida’s Order of Suspension. Service at attorney Runyan’s court record address was returned – “Return To Sender – Not Deliverable as Addressed – Unable to Forward” and service at her Florida Bar address was signed for by Cindy Runyan.

Rule 5(a) of the Rules Governing Attorney Discipline, Local Rules of the United States District Court for the Southern District of Florida, requires that “[a]n attorney admitted to practice before this Court shall, upon being subjected to suspension or disbarment . . . promptly inform the Clerk of the Court of such action.” Rule 5(d) provides in pertinent part that after expiration of the time for submitting a response to an Order to Show Cause, “the Court may impose the identical discipline or may impose any other sanction the Court may deem appropriate.” Given this background, pursuant to Rule 5(a) and (d) and the Court’s inherent power to regulate membership in its bar for the protection of the public interest, *see Chambers v. NASCO, Inc.*, 501 U.S. 32, 43 (1991) (“[A] federal court has the power to control admission to its bar and to discipline attorneys

who appear before it.”),

IT IS ORDERED that said attorney be suspended from practice in this Court, effective immediately. The attorney may not resume the practice of law before this Court until reinstated by order of this Court. *See* Rule 9(a). The Clerk of Court shall strike this attorney from the roll of attorneys eligible to practice in the United States District Court for the Southern District of Florida, and shall also immediately revoke the attorney’s CM/ECF password.

IT IS FURTHER ORDERED by this Court that said attorney advise the Clerk of Court of all pending cases before this Court in which she is counsel or co-counsel of record.

IT IS FURTHER ORDERED by this Court that the Clerk of Court attempt to serve by certified mail a copy of this Order of Suspension upon the attorney at her Florida Bar address.
