## **ORDER ADOPTING REPORT AND RECOMMENDATION**

The Ad Hoc Committee on Attorney Admissions, Peer Review, and Attorney Grievance (the "Committee") received a referral, pursuant to Rule 5(b)(1) of the Special Rules Governing the Admission and Practice of Attorneys, Local Rules of the United States District Court for the Southern District of Florida, by District Judge Cecilia M. Altonaga regarding the conduct of Kevin Lawrence Hagen in the case of *Unilin Beheer B.V., et al. v. US Wood Flooring, Inc., et al.*, Case No. 17-cv-60107-CMA (S.D. Fla. 2017). Judge Altonaga referred the matter to the Committee due to Mr. Hagen's "repeated failures to comply with [Court] Orders." (ECF No. 45). An Initial Screening Committee was convened to investigate Mr. Hagen's conduct. On May 1, 2017, Mr. Hagen met with a subcommittee and on August 22, 2017, he appeared before the full Committee for a hearing.

On September 28, 2017, the Committee submitted its Report and Recommendation. In the Report, the Committee detailed Mr. Hagen's repeated failure to comply with Judge Altonaga's orders, insufficient explanations for failure to comply with the Court's orders, and two previous disciplinary actions with The Florida Bar that resulted in an admonishment and in a public reprimand (Case Nos. SC07-1748 and SC09-2019). Upon consideration of the Committee's Report and Recommendation and a review of Mr. Hagen's disciplinary file, it is hereby

ORDERED AND ADJUDGED that the Committee's Report and Recommendation is ADOPTED and the matter is CLOSED.

IT IS FURTHER ORDERED as follows:

- 1. For a six month period, beginning from the date of this Order, Mr. Hagen is suspended from accepting any new cases in the Southern District.
- 2. Mr. Hagen is required to attend appropriate training with the Diversion/Discipline Consultation Services (formerly LOMAS) and shall provide a report or summary from the Division/Discipline Consultation Services to the Committee. Mr. Hagen must attend this training and provide a report or summary of attendance during the six month period following the date of this Order.
- 3. Mr. Hagen is hereby publicly reprimanded for his repeated refusal to comply with orders entered by a Court in this District.
