

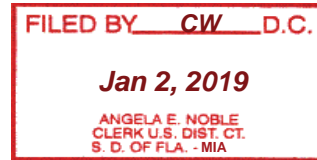

Pursuant to the authority conferred by Title 28, United States Code, Section 631, et seq., and the authority granted in action taken by the Judicial Conference of the United States, it is hereby

ORDERED that Jacqueline Becerra be appointed as full-time United States Magistrate Judge at Miami, Florida, at an annual salary as fixed by the Judicial Conference of the United States. It being further

ORDERED that United States Magistrate Judge Jacqueline Becerra shall commence performance of her duties on the 5<sup>th</sup> day of January, 2019, upon taking the oath or affirmation prescribed by Title 28, United States Code, Sections 453 and 631(g), and shall hold and discharge the duties of her office for a term of eight years from the date of this appointment, subject to the provisions of Title 28, United States Code, Section 631(e), unless sooner relieved.

The Clerk will cause certified copies of this Order to be entered upon the record of this Court, and shall forward a certified copy of this Order and the appropriate documents of appointment to the Director of the Administrative Office of the United States Courts. It is further

ORDERED that starting January 5, 2019, Magistrate Judge Jacqueline Becerra shall be assigned those cases that would have been assigned to Chief Magistrate Judge Andrea M. Simonton under the current Magistrate Judge Pairing Plan, and all matters currently referred or assigned to Chief Magistrate Judge Andrea M. Simonton, shall be re-referred or reassigned to Magistrate Judge Jacqueline Becerra effective as of the signing of this Order.
