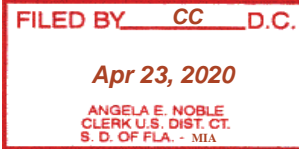

ORDER OF REINSTATEMENT

THIS CAUSE is before the Court on the Report and Recommendation of the Ad Hoc Committee on Attorney Admissions, Peer Review, and Attorney Grievance (the “Committee”). (“Report and Recommendation”) (ECF No. 8). This Report and Recommendation is in response to the February 7, 2020, Order Terminating Suspension entered by Southern District of Florida Bankruptcy Judge John K. Olson, which terminated attorney Maite L. Diaz’s suspension in that Court. *See In re: Aldo A. Pina*, 602 B.R. 72 (Bankr. S.D. Fla. 2019) (“Order of Termination”) (ECF No. 7). Diaz was suspended by Bankruptcy Judge Olson on June 25, 2019 (“Order of Suspension”) (ECF No. 1) and reciprocally disciplined by this Court on September 24, 2019 (Administrative Order 2019-73) (ECF No. 6). In the Report and Recommendation, the Committee found that the suspension currently served by Diaz was appropriate and that she has satisfied the concerns raised over her law practice management skills. (ECF No. 8). The Committee recommends reinstatement, consistent with Bankruptcy Judge Olson’s Order of Termination. *Id.*

Pursuant to Rule 12(d) of this Court’s Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys and the inherent authority of this Court to oversee officers admitted to membership in its bar, *see Chambers v. NASCO, Inc.*, 501 U.S. 32, 43 (1991) (“[A] federal court has the power to control admission to its bar and to discipline attorneys who appear before it.”), upon consideration of the Report and Recommendation and being otherwise fully advised in the matter, the Court finds that Diaz qualifies for reinstatement to this Court’s Bar. Accordingly, this Court ORDERS that Diaz be reinstated as a member in good standing to the Bar of this Court. It is hereby

ORDERED AND ADJUDGED that the Committee's Report and Recommendation is ADOPTED, and Diaz be reinstated as a member in good standing to the Bar of this Court.
