ORDER ON PETITION FOR REINSTATEMENT

THIS CAUSE is before the Court on attorney Lavenia Dianne Mason's n/k/a Lavenia Dianne Santos's Petition for Reinstatement to Practice in the United States District Court for the Southern District of Florida. Ms. Mason/Santos was reciprocally disciplined by this Court based upon an Order of Disbarment by the Supreme Court of Florida. *See The Florida Bar v. Mason,* No. SC00-997 (Fla. March 14, 2002) and Administrative Order 2002-23. The March 14 Order by the Florida Supreme Court was withdrawn on August 29, 2002 and substituted with an Order of Suspension for two (2) years. *See The Florida Bar v. Mason,* No. SC00-997, 826 So. 2d 985 (Fla. Aug. 29, 2002). On November 5, 2014, Ms. Mason/Santos filed a Petition for Reinstatement with the Florida Supreme Court. After consideration of an uncontested report of the referee, the Supreme Court of Florida issued an Order of Reinstatement on June 16, 2015, reinstating Ms. Mason/Santos as a member in good standing of The Florida Bar. *See The Florida Bar re: Santos,* No. SC14-2157, 171 So. 3d 123 (Fla. June 16, 2015).

Pursuant to Rule 12(c) of this Court's Rules Governing the Admission, Practice, Peer Review, and Discipline of Attorneys, upon consideration of the Petition, attachments to the Petition, and being otherwise fully advised, the Court finds that Ms. Mason/Santos qualifies for reinstatement to this Court's Bar. Accordingly, the Court **GRANTS** Ms. Mason/Santos's Petition

for Reinstatement and orders that she be reinstated as a member in good standing to the bar of this Court.
